By signing this form you agree to the following terms and conditions.

All Funds are NON-REFUNDABLE. All vending items left in the park unattended / overnight is at vendors own risk. In no event shall the liability of Organizers of Muslim Day Event to the Vendor for any claim whatsoever related to this agreement exceed the total amount of payments made under this Agreement by the Vendor to the Organizers of Muslim Day event with respect to this agreement. The Organizers of Muslim Day Event disclaims all liability whatsoever to the Vendor or any other party for consequential, indirect, incidental, special or such other damages including but not limited to, any damage for lost profits or loss of business, even if the Organizers of Muslim Day Event has been advised of the possibility of such damages. Neither party will be liable to the other by reason of any failure in performance of this Agreement if the failure arises out of the unavailability of facilities or energy sources, acts of God, acts of the other party, acts of governmental authority, fires, strikes, robbery, delays in transportation, riots, terrorism, war, or any causes beyond the reasonable control of that party. This Agreement shall be interpreted and enforced: in accordance with the laws of the Fulton County, Georgia, U.S.A. The parties agree that no action by one party against the other may be brought in any court, in any jurisdiction, except according to the terms of this Section. If any part of this Agreement is held to be illegal or unenforceable, the validity or enforceability of the remainder of this Agreement shall not be affected and such provision shall be deemed modified to the minimum extent necessary to make such provision consistent with applicable law and, in its modified form, such provision shall then be enforceable and enforced. The Vendor agrees to follow all rules and regulations established by the Organizers of Muslim Day Event. The Vendor accepts the responsibility to clean the booth area designated to them at the end of the Muslim Day Event. The Vendor also understands that failing to clean designated booth area may result in additional \$100 cleanup fee payable by the Vendor to the Organizers of Muslim Day Event.

The Non-Food Vendors WILL NOT sell / display any edible item including water, any type of juice, soft drinks, sodas, tea or coffee. NO EXCEPTIONS.
